



## JELD-WEN Best of LaCantina Contest Official Rules No Purchase Necessary

The JELD-WEN Best of LaCantina Contest (the “**Contest**”) is sponsored by JELD-WEN, Inc., 2645 Silver Crescent Drive, Charlotte, NC 28273 (“**JELD-WEN**” or “**Sponsor**”), and administrated by Architizer Inc., 1 Whitehall Street, 14th Floor New York, New York 10004 (“**Administrator**”). By entering, each Entrant accepts and agrees to be bound by these Official Rules.

This Contest is comprised of four (4) requirements: Entrants must (1) submit entries at: <https://bestoflacantina.secure-platform.com/a/>, (2) complete the registration/submission form, and (3) submit at least three (3) images of the project where Entrant utilized LaCantina folding, sliding, or swing doors, (4) during the Contest Period.

**CONTEST DESCRIPTION.** The Contest is a promotion where a Grand Prize will be awarded to the winner of the Best of LaCantina “Best in Show” award; additional Honorable Mention prizes may be awarded in the judge’s discretion. The Grand Prize will be awarded and fulfilled by JELD-WEN. Other entrants will be selected as winners in additional categories (Best Commercial, Best Rural Residential, Best Urban Residential, Best Suburban Residential, Best Compact, Best Renovation and Most Innovative) but will not be awarded a Grand Prize.

1. **CONTEST PERIOD.** The **Contest Period** begins August 4, 2025, at 8:00:01 a.m. U.S. Eastern Standard Time (EST) and ends September 26, 2025, at 11:59:59 p.m. EST. All entries must be received by September 26, 2025, at 11:59:59 p.m. EST. Note: JELD-WEN’s computer is the official timekeeping device for the Contest Period.
2. **ELIGIBILITY:** Participation in the Contest is open only to legal residents of the 50 United States and District of Columbia who are 18 years of age or older on the date of the Contest entry submission, and who meet all of the following requirements:

Other entries (at the judges' discretion) may receive Honorable Mention recognition. The winning designs will also be featured on [lacantinadoors.com](http://lacantinadoors.com) and on [Architizer.com](http://Architizer.com) and shared with Administrator's 4,000,000+ social media fans. All prizes are non-transferable and non-substitutable. All applicable taxes on value of the prizes are the responsibility of the recipient.
